ACCOMMODATION

Composite double glazed entrance door leading into:

ENTRANCE HALLWAY

With stairs rising to the first floor accommodation and door giving access to:

LOUNGE

13'10" x 11'10" (4.24m x 3.61m)

uPVC double glazed window to the front elevation, radiator and fireplace housing multi fuel stove. Door in turn giving access to:

BREAKFAST KITCHEN

14'10" x 7'3" (4.54m x 2.22m)

uPVC double glazed entrance door to the rear elevation giving access out to the garden and uPVC double glazed window to the rear elevation, contemporary fitted kitchen comprising base, drawer and wall units with complementary work surface, tiled splashback, inset stainless steel sink and drainer with mixer tap over, space for cooker, provision for automatic washing machine, space for further low level appliance and breakfast bar with radiator under. Folding door gives access into useful under stairs storage area with power allowing provision for further appliances.

FIRST FLOOR LANDING

Loft access, radiator and doors giving access to:

BEDROOM ONE

12'0" x 10'7" (3.66m x 3.25m)

uPVC double glazed window to the front elevation, radiator and doorway into useful closet space.

BEDROOM TWO

10'9" x 8'4" (3.30m x 2.55m)

uPVC double glazed window to the rear elevation, radiator and fitted linen cupboard housing the gas fired central heating boiler.

SHOWER ROOM

6'9" x 6'2" (2.08m x 1.89m)

uPVC double glazed window to the rear elevation, suite comprising w.c. hand basin mounted in vanity unit and walk in double shower with mermaid boarding splash backs, chrome heated towel rail and tiled flooring.

EXTERNALLY

To the front is a hedge lined garden with low maintenance astroturf and pathway leading to the front entrance door. To the rear is an enclosed low maintenance garden with patio area, low maintenance astroturf and decking feature to the rear. Space for garden shed.

Road Map



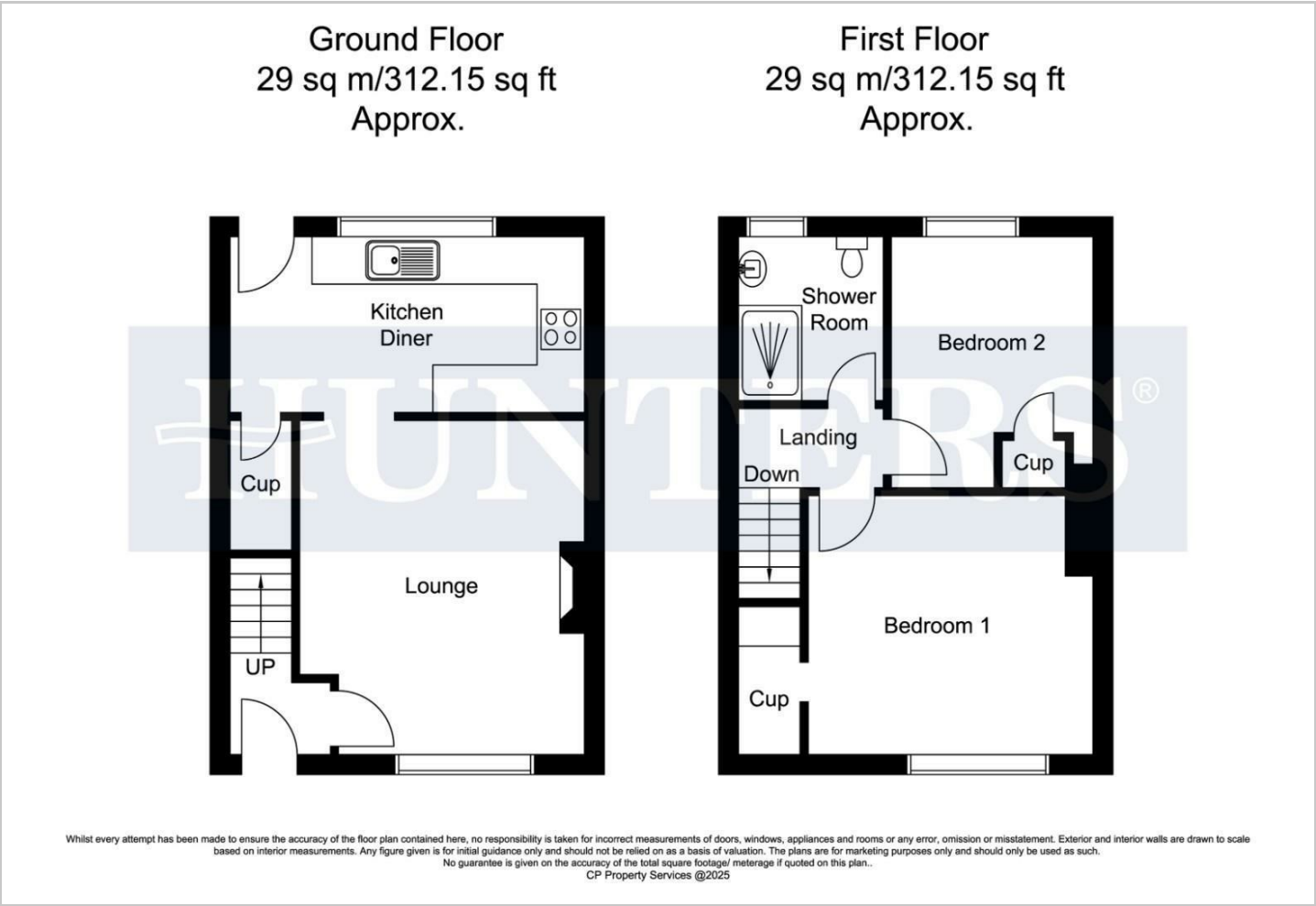
Hybrid Map



Terrain Map



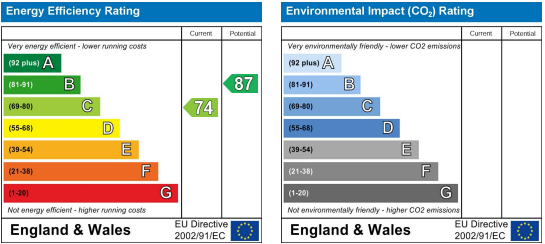
Floor Plan
