## **EASEMENTS. WAYLEAVES & RIGHTS OF WAY**

The land is sold subject to and with the benefit of all rights of way, drainage, water courses, light and other easements, quasi or reputed easements and rights of adjoining landowners (if any) affecting the same and all matters registerable by any competent authority pursuant subject to statute.

The land is crossed by two paths which are not shown highlighted on the definitive map. The vendor believes the aforementioned paths are public footpaths. A public right of way runs adjacent to the southern boundary.

The land is freehold, and the title is registered under title number ND184144. Vacant possession is available on completion.

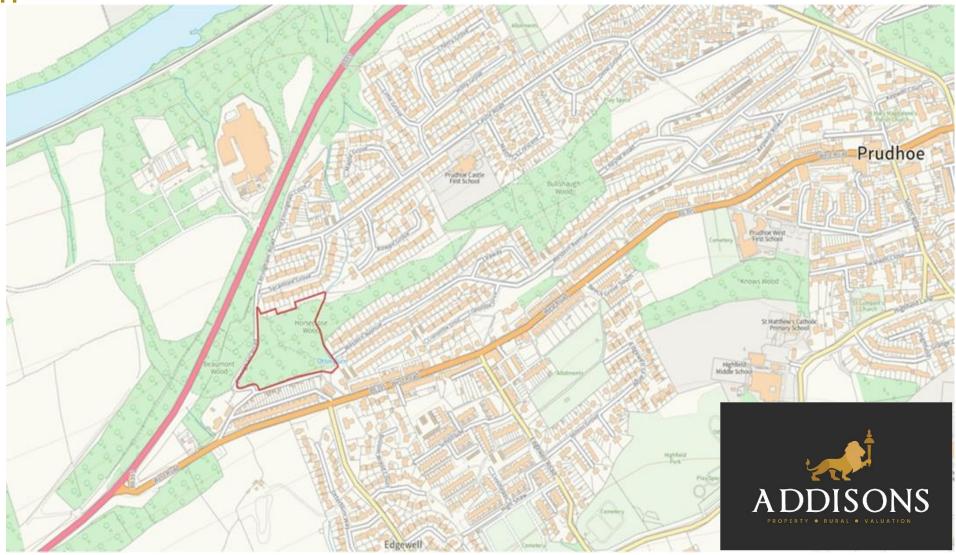
