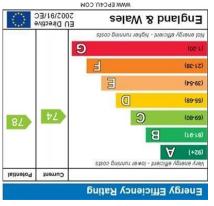

Property Description

A beautifully presented three bedroom deta ched family home. the house was built as a four bedroom property with a double garage. The first floor has been converted to three double bedrooms and the double garage has been converted to provide a further ground floor double bedroom and studio / study area, however can easily be converted back to a functioning garage as the door is still in situ!

A very versa tile family home suiting lots of different family dynamics!

Approach via the large driveway which has gravelled area, providing parking for at least 3 cars with a further parking space op posite, shrub and plant borders surround the boundaries lyeading to newly fitted front door into:-

SPACIOUS HALLWAY With wood effect flooring, stairs leading to the first floor.

GUEST WC With low level wc, wash hand basin with vanity, storage area under the stairs, wood effect flooring and central heating radiator.

FAMILY ROOM / BED ROOM FOUR 16' 3" \times 7' 8" (4.95m \times 2.34m) This was originally one of the double garages, making a generous ground floor bedroom , having double glazed window to front, two central heating radiators, door leading into:-

GARAGE AREA / STUDIO 9' 10" x 8' 4" (3m x 2.54m) Currently being used as a dance room, can be put back to a garage very easily, having an up and over door, power and lighting and leads to:-

REAR STO RAGE AREA $8'10" \times 8'8"$ (2.69m $\times 2.64m$) Having central heating boiler, door leading out to the side.

OPEN PLAN KITCHEN DINING BREAKFAST AREA 10'6" x 23'7" (3.2m x 7.19m) Having wood effect flooring, bi-fold doors to the rear, two double glazed windows to rear, sink with mixer tap, integrated oven, microwa ve, dish washer, five ring gas hob, extractor over, breakfast bar area with lighting, a range of wall and base units and work surfaces, spotlighting.
