





A superb village property consisting of a splitlevel bungalow with attached converted barns including a leisure room and indoor swimming pool

The property is a spacious and highly versatile bungalow that was purpose built by the late vendor. It has an abundance of character and the accommodation can be adapted to suit a variety of needs.

The front door opens to the entrance hall. All of the rooms are vaulted adding to the feeling of space. To one end is the principal bedroom suite with views over the garden and fitted furniture. There is an impressive double aspect sitting room with large feature fireplace. Next to this is a dining room also with views over the garden. The kitchen/breakfast room is fitted with a comprehensive range of farmhouse style units and range cooker. There is a cloakroom and utility room. Steps lead down to the lower area with access to two further double bedrooms and a bathroom. There is a library at the far end which could be used as a fourth bedroom. A door leads to the leisure/games room which in turn aives access to the large indoor swimming pool. There are two changing rooms, both with showers and a separate w.c.

The property is approached via a

gravel driveway with parking for several cars and an integral garage. The gardens are a delightful feature, laid principally to lawn with wide array of mature shrubs and trees. There is a superb inner courtyard that can be used for alfresco dining.

LOCATION

Fressingfield is a thriving village which is very popular due to its diverse range of amenities. It is home to the nationally renowned Fox & Goose restaurant, there are also a variety of social clubs, a local primary school and doctors surgery. Harleston is approximately 5 miles and has an excellent range of independently owned shops along with a supermarket, doctors and schools.
