### LOCATION

The site is located south of the River South Tyne adjoining the popular Showfield development.

Haydon Bridge is a popular village with an excellent range of local services and amenities including a small supermarket, butchers, post office and pharmacy. The market town of Hexham is just 6.5 miles to the east providing a wider range of amenities.

There is a railway station just over 900m by foot in Haydon Bridge and also one in Hexham which provide further links east and west. The A69 is in close proximity providing excellent road links east to Newcastle and west to Carlisle with onward access to the A1 and M6 making the village ideal for commuters. Newcastle International Airport is located 26 miles to the east.

#### **LEGALS**


