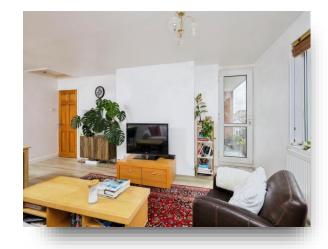

Double glazed window to the side aspect. Radiator.

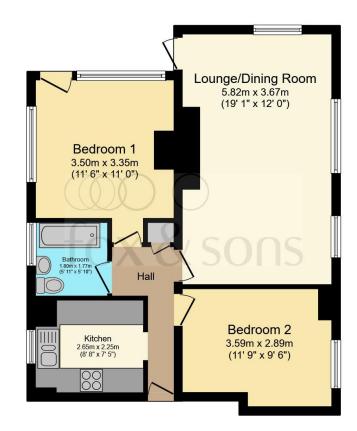
