From Fox and Sons, Eastleigh. Get on M3 from A335

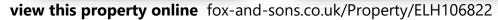

Follow M3 and A34 to Winchester St. Take the exit towards

Overton/B3400/Whitchurch/Tufton from A34. Merge onto M3
