



A unique opportunity to purchase a spacious town house that is currently being used as a restaurant on the ground floor with accommodation above. Internally this property is split over 5 floors, with the basement and ground floor being used for the restaurant. The basement locates the kitchen and storeroom with the ground floor offering the restaurant and bar area with toilets for the guests. To the first floor you will find the main kitchen and a spacious lounge, with a utility room and a bedroom with an en suite. The second floor provides a secondary kitchen area, two shower rooms and a further three bedrooms, whilst the third floor can be accessed via two separate staircases. One leads to three bedrooms whilst the other leads to a further three bedrooms and a separate bathroom. If you are looking for a new project, a business opportunity or just a substantial sized property, this one is well worth a look! An additional feature to the property is the 'smugglers cave'. The property has access to a 200 year old smugglers cave which used to be interconnected throughout Hasting beach properties. Currently blocked and used as a storage space.


