### **Auctioneer's Comments**

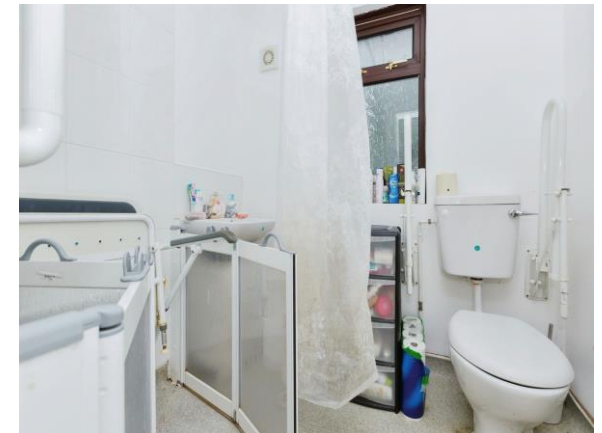

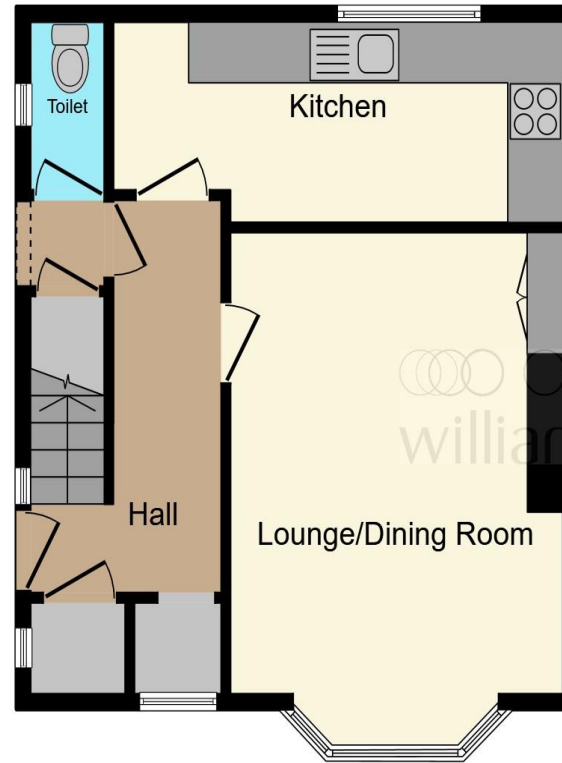

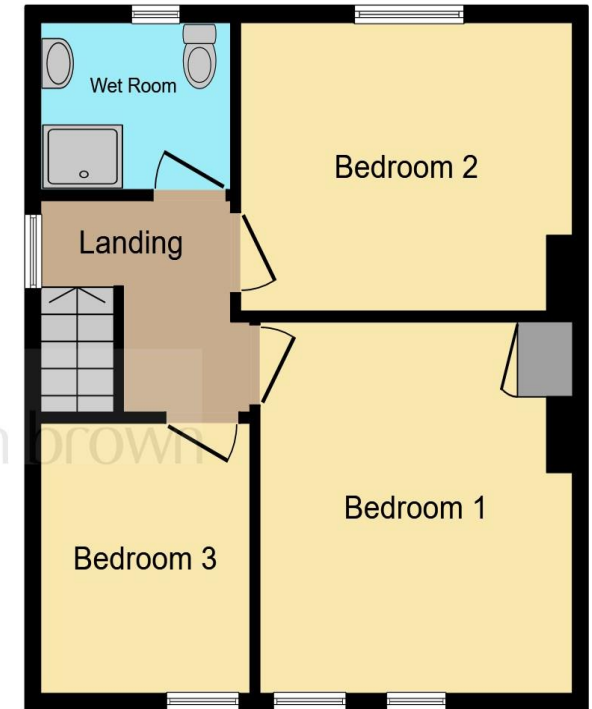
