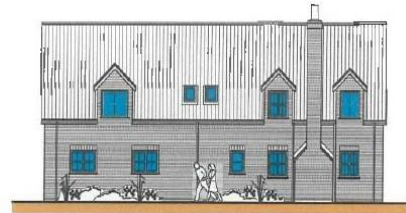




Front Elevation (N)

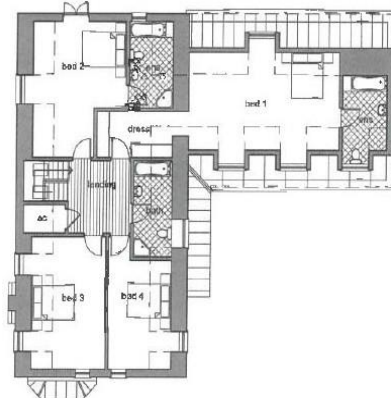
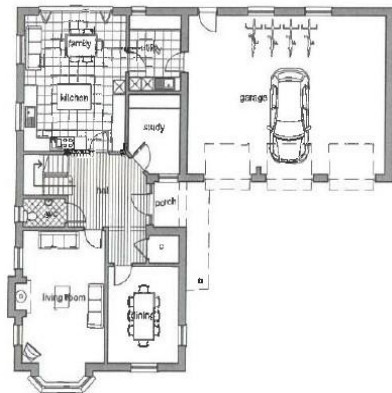
Side Elevation (W)
