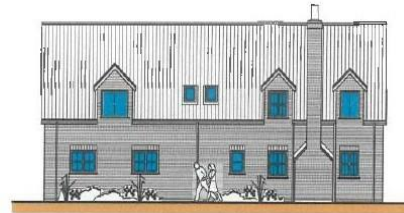




Front Elevation (N)

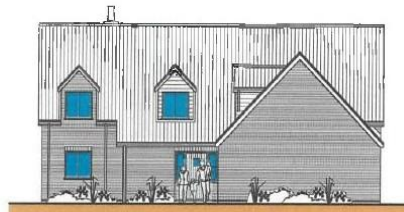
Side Elevation (W)

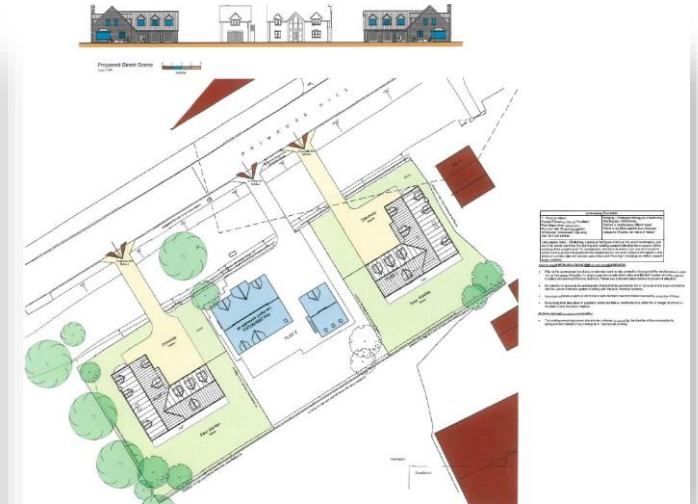
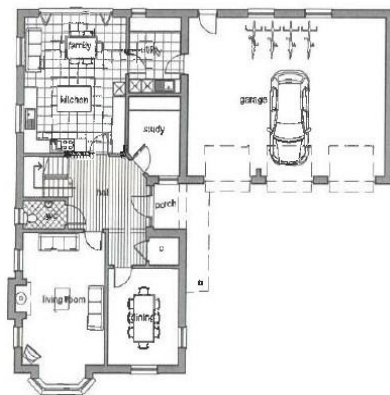
Rear Elevation (S)
