



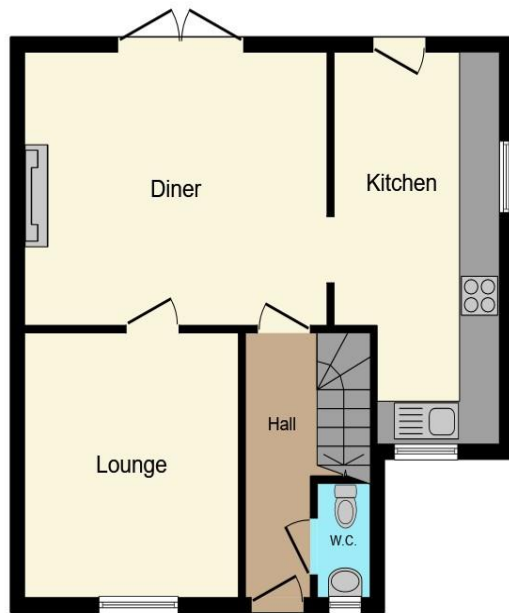

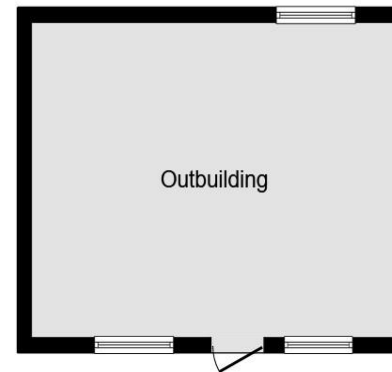




Ground Floor
