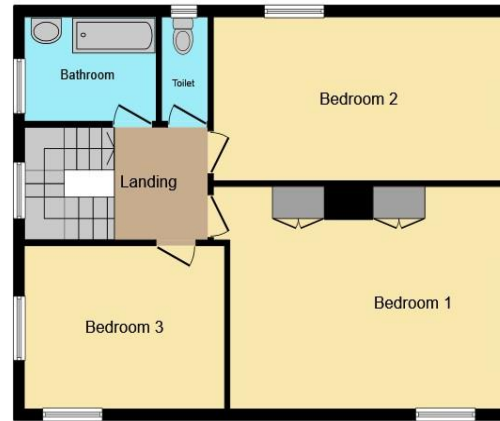

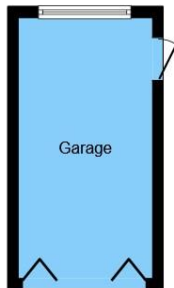




Ground Floor
