Suite comprising bath with mixer tap and shower over, WC, wash hand basin, heated towel rail, extractor fan, part tiled walls, laminate flooring and a double glazed window to the rear aspect with fitted blinds.

## Exterior

Externally, the property offers one allocated parking space and an enclosed decking area with space for seating.


