













Ground Floor



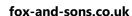
