# Door To Entrance Hall Lounge

16' 1" max x 11' 7" max ( 4.90m max x 3.53m max ) Feature fireplace. Double glazed window to front and side. Turning staircase to first floor.

## **Dining Room**

11' 7" max x 11' 3" max ( 3.53m max x 3.43m max ) Feature fireplace. Turning staircase to first floor. Double glazed window to front.

### Kitchen/Breakfast Room

27' 2" max x 11' 1" ( 8.28m max x 3.38m )

Superb open plan fitted kitchen/breakfast room with feature central island with twin inset sinks and mixer taps, generous range of base and wall units, built in dishwasher, integrated microwave, built in fridge, tiled floor, bi-fold opening onto lovely landscaped garden, staircase to bedroom.

#### **Door To Side Hall**

Doors off to ground floor bathroom and utility.

#### **Ground Floor Bathroom**

Lovely fitted suite comprising large shower, bath, low flush WC, heated towel rail, wash hand basin set into vanity unit, double glazed window to rear.

## **Utility Room**

Fitted with a generous range of base and wall units, space and plumbing for automatic washing machine and tumble dryer, sink with mixer tap and work surface surround, double glazed window to rear, storage cupboard, door to front.

#### **Bedroom Four**

#### **Bedroom Two**

16' 7" max x 11' 7" max ( 5.05m max x 3.53m max ) Accessed via a staircase from the lounge. Built in cupboard. Double glazed window to front.

## **Bedroom Three**

14' 10"  $\times$  11' 7" (  $4.52m \times 3.53m$  ) Accessed via staircase from dining room. Double glazed window to side. Built in storage cupboard.

#### **Bedroom Five**

13' 10" x 9' 2" ( 4.22m x 2.79m ) Accessed via staircase from kitchen. Double glazed window to rear.

#### Outside Rear Garden

Paved terrace leads to a landscaped garden which is predominantly laid to lawn with fence surround. To one corner there is a covered entertaining area and a further paved terrace.

## Garage

Detached garage with double doors and personal door to garden. Further parking for 3 cars.
