Lounge

14' x 12' 1" staircase present (4.27m x 3.68m staircase present)

Double-glazed window to front, radiator, and colonial door.

Kitchen

12' x 7' 6" (3.66m x 2.29m)

Fitted kitchen with the range of wall and base cupboards, work tops, cooker hood, sink and drainer, central heating boiler, plumbing for a washing machine, radiator, electric oven, gas hob, double-glazed French doors leads into the rear garden, tiling to the walls, cushion flooring, colonial door, double-glazed window to rear aspect, and a cloakroom and cupboard off kitchen.

Lawned garden with timber shed and timber fencing forming boundary.
