Double glazed window to front, vanity wash hand basin with drawers under, low level WC, shower cubicle, heated towel rail, exposed beams, laminate floor.

The rear courtyard gives access to stone outbuildings, outside oil fired boiler, steps lead up to a raised seating area where the oil tank can be found, flower and shrub beds, bordered by fencing and walling.

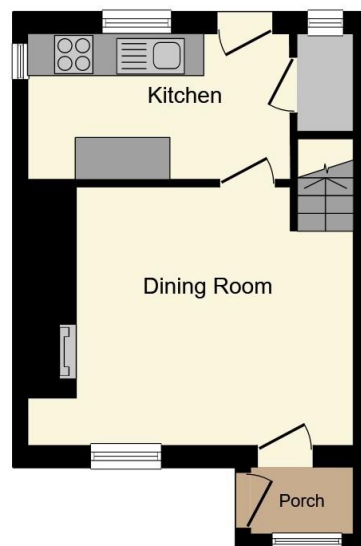

Location

Timberscombe itself is served together with church, village hall, post office and inn. There is also a primary school and pre-school in the village. The historic village of Dunster is approximately two miles away and West Somerset's premier coastal resort of Minehead which has an excellent range of shopping, banking and recreational facilities is approximately six miles. The county town of Taunton is approximately twenty miles to the east and has mainline rail connections and access to the motorway network. The property is situated within the Exmoor National Park and is ideally placed to explore the rolling Exmoor Hills and the nearby Quantock Hills and the coast is also close at hand.

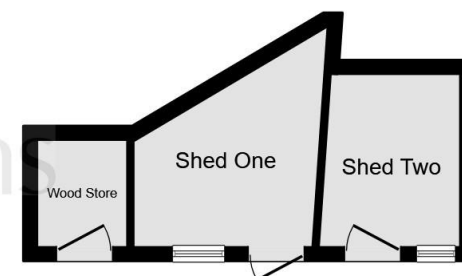
