#### Entrance

Entrance door leads into the Hallway which has radiator, storage cupboard, loft hatch access and doors leading into the following rooms:

#### Lounge/diner

20' 11" x 12' 7" max ( 6.38m x 3.84m max ) Dual aspect with a window to the front and side, 2 radiators and a gas fire with mantle and surround.

#### Kitchen

9' 2" x 8' 3" ( 2.79m x 2.51m ) Comprising of modern wall, base and drawer units with worktop space over, integrated oven, microwave, hob, extractor, sink, window and door into:

#### Lean To

13' 10" x 5' 5" (  $4.22m\ x$  1.65m ) This space offers plumbing for a washing machine. There is also a window and door leading externally.

#### **Bedroom One**

10' 10" x 10' 5" ( 3.30m x 3.17m ) Has a window, radiator and built in wardrobes.

#### **Bedroom Two**

8' 10" x 7' 10" ( 2.69m x 2.39m ) Has a window and radiator.

**Bedroom Three** 9' 3" x 10' 10" ( 2.82m x 3.30m )

Has a sliding door into sun room and a radiator.

7' 1" x 6' 10" ( 2.16m x 2.08m ) Has windows to 3 elevations and a door leading externally.

Has a walk in shower, sink with vanity storage below, WC, radiator and an opaque window.
