Entrance Hall

Following from the entrance door there is an electric radiator, stairs leading to the first floor and doors leading into:

Lounge

14' 4" min to bay x 12' 11" (4.37m min to bay x 3.94m) has a bay window to the front elevation, radiator and a window to the side.

Kitchen

12' 3" x 10' 10" (3.73m x 3.30m)

Comprises of wall & base units with worktop space over, sink, hob, extractor fan, a window and door to the side and a door into the pantry (4" x 8")

Bedroom One

14' \times 10' 11" min to bay ($4.27m \times 3.33m$ min to bay) Has a bay window to the front elevation and a radiator.

Bedroom Two/ Dining

14' x 9' 11" (4.27m x 3.02m)

Currently being used as a dining room, this room consists of a window and a radiator.

Bedroom Three

14' x 9' (4.27m x 2.74m) Has a radiator and a window.

Bathroom

Comprises of a bath with shower over, sink with vanity and a storage cupboard.

Wc

Has a WC and a window.

Has loft storage and a door into:

15' 11" x 17' 9" max into bay ($4.85m \times 5.41m$ max into bay) Consists of a bay window.

External

Low maintenance gardens to both front & rear.To the front of the property there is a gravelled driveway leading to the garage and fencing around.

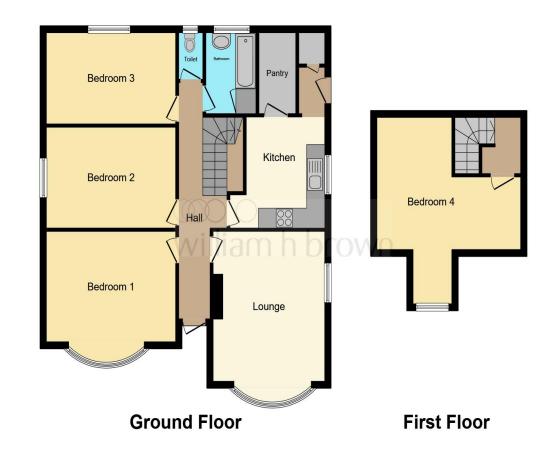
