8' 6" x 7' 7" ( 2.59m x 2.31m ) Has a window and radiator.

#### **Bathroom**

Has a bath with shower over, sink, WC, radiator and window.

Externally, the property benefits from a driveway. The rear is a good size garden offering lawned space, patio space and shed.

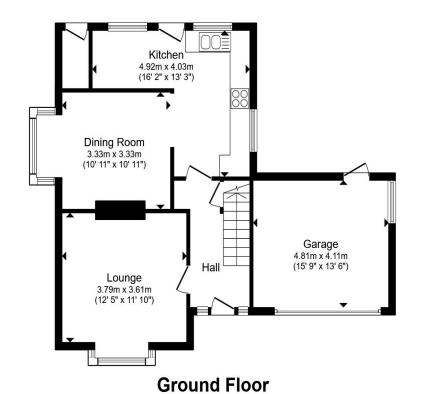
