Double glazed window to side aspect. Double glazed patio doors leading to rear garden. Stairs rising to first floor. Radiator. Doorway to:-

**Kitchen**

Fitted kitchen with a range of matching wall and base units over areas of work surface. Stainless steel sink and drainer unit. Integral oven with hob and hood over. Space for appliances. Extractor fan.

**Landing**

Access to loft room.

**Bedroom One**

Double glazed window to rear aspect. Radiator.

**Bedroom Two**

Double glazed window to side aspect. Built in wardrobe, radiator.

**Loft Room**

Double glazed window to side aspect. Velux window. Central heating boiler. Radiator.

**Exterior**

A door leads to the garage with parking in front. There is also an additional parking space. The garden has a patio seating terrace (currently with a hot tub). The remainder is predominantly laid to lawn with a further seating area to the rear. Gate to front. Storage shed.

**Garage**

Power and lighting connected. Up and over door.
