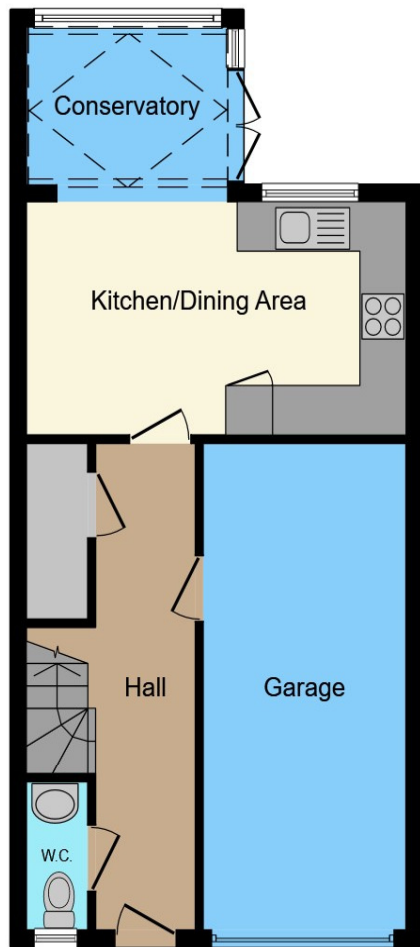

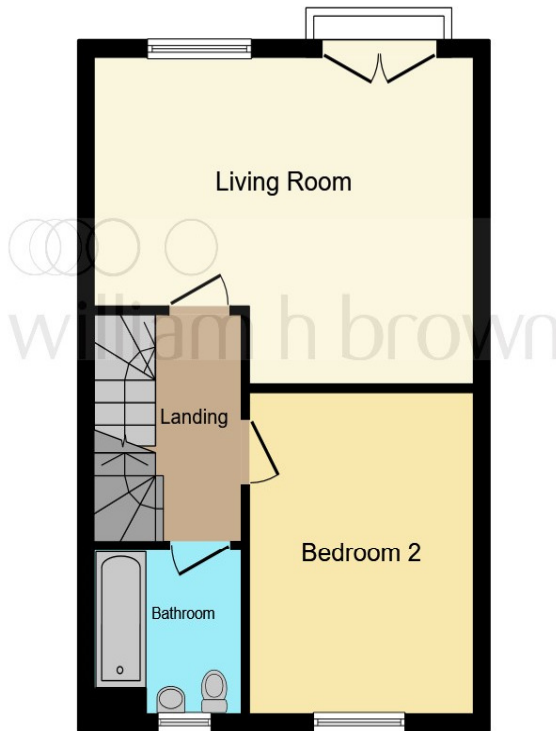

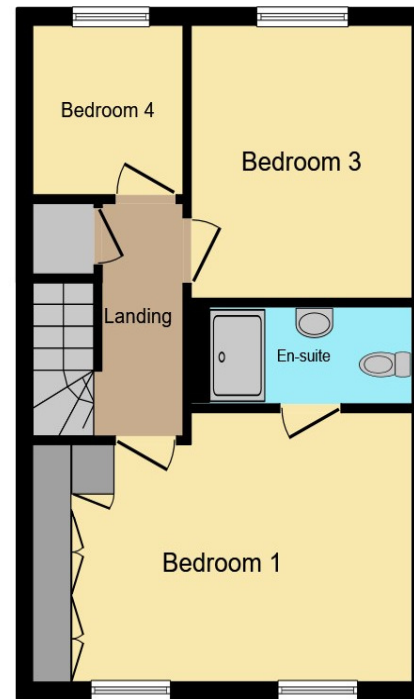




**Ground Floor**
