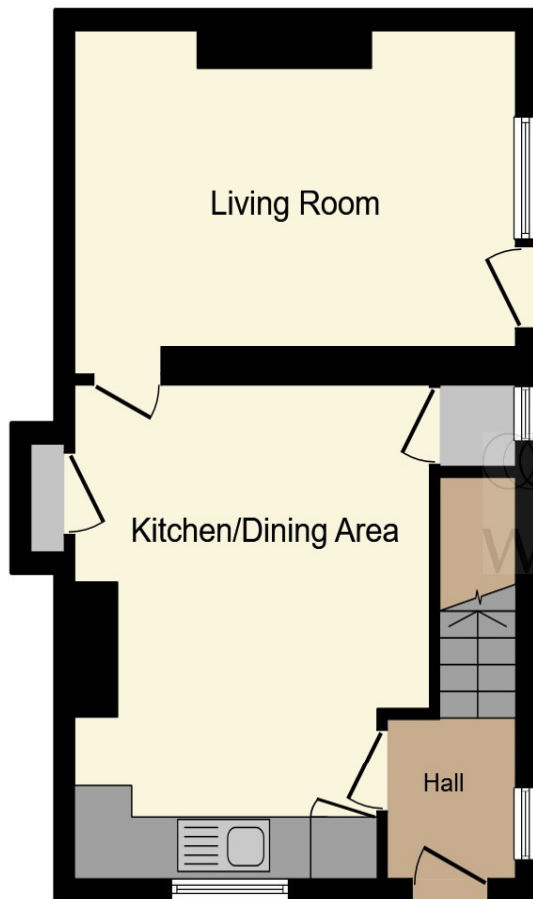

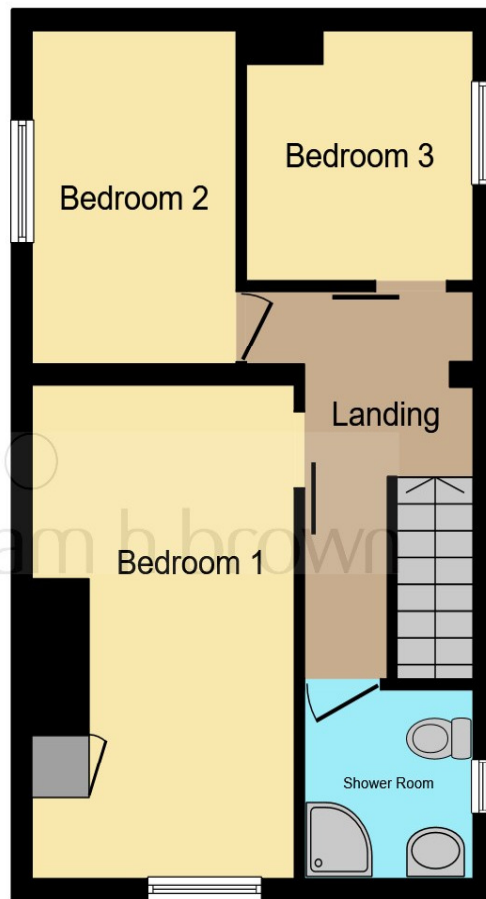

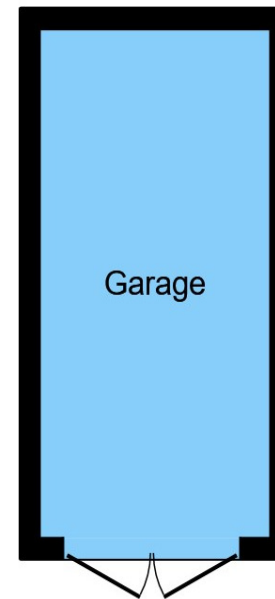




Ground Floor
