The ground floor comprises of entrance hall, downstairs cloakroom, large lounge, kitchen, dining room and conservatory with door to the rear garden. Upstairs offers three bedrooms, bathroom with separate W/C and landing with loft access. Externally there is a family sized garden and on-street parking.

This property is offered through Modern Method of Auction. Should you view, offer or bid your data will be shared with the Auctioneer, iamsold Limited.
