The existing site currently comprises 2 x three-bedroom flats, both tenanted and producing a combined annual income of approximately £27,000, offering an immediate income stream while development plans are progressed.

Planning permission (Fenland District Council ref: F/YR23/0976/O) allows for the erection of up to four two-storey homes and two single-storey dwellings, along with the formation of a new access, subject to the demolition of two existing dwellings and associated outbuildings.

Located within easy reach of Wisbech town centre, schools, and road links, the site balances convenience with future value - ideal for small-scale residential development in a well-connected location.
