#### **Entrance Hall**

The entrance hall has beautiful tiled flooring, a newly fitted composite front door and a door into the lounge.

#### Lounge

14' 1" into recess x 11' 11" ( 4.29m into recess x 3.63m ) A lovely lounge with carpeted floors, a radiator, a window to the front and double doors on to the dining room.

### **Dining Room**

14' 1" into recess x 9' 6" max ( 4.29m into recess x 2.90m max )

The dining room has carpeted floors, a radiator, the stairs up to the first floor and double doors in to the lounge.

#### Kitchen

10' 11" x 5' 11" ( 3.33m x 1.80m )

A newly fitted kitchen with wall/base units, a hob, an oven, a cooker hood, a radiator, a combi boiler (gas central heating), a window to the side, plumbing for a washing machine and laminate flooring.

## Landing

A carpeted landing with a ladder up to the loft space.

### **Bedroom One**

14' 1" into recess  $\times$  8' 11" ( 4.29m into recess  $\times$  2.72m ) The first double bedroom has carpeted floors, a radiator and a window looking over the front of the home.

#### **Bedroom Two**

10' 7" into recess x 9' 6" ( 3.23m into recess x 2.90m ) The second double bedroom has carpeted floors, a radiator, a window to the rear and built in storage.

#### **Bathroom**

The bathroom is to the ground floor with a shower over the claw foot bath tub, a w.c, a wash hand basin, a radiator, a window to the side and lovely, checkerboard tile flooring.

### **Loft Space**

13' x 10' 9" ( 3.96m x 3.28m )

There is a versatile loft space which is accessed via the landing, with a sky light, carpeted floors, power sockets and lighting.

#### Exterior
