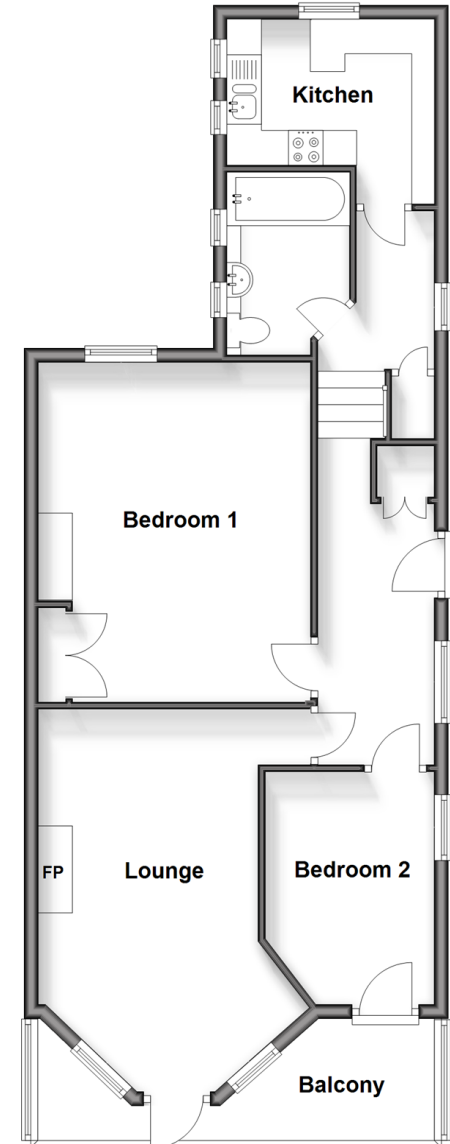

## Auctioneer's Comments
