#### Situation


The land is located to the south of the village of Eaton in Leicestershire and has vehicular access directly off Waltham Lane.

#### The Farmland

The land extends to approximately 27.03 acres (10.94 hectares) in total.

The soil is classified as Grade 3 by the Agricultural Land Classification of England and Wales and is predominately of the Denchworth soil association, being described as slowly permeable seasonally wet slightly acid but base rich loamy and clayey soils suited to grassland and arable. Part of the land is also of the Banbury soil association, described as freely draining slightly acid but base-rich soils again suited to grassland and arable.

The arable land has been drilled with spring oats for harvest 2025. A cropping history is available from the vendor's agent upon request.
