Situation

Erlestoke lies within a conservation area and has a Church, cricket club and 18 hole golf course. Nearby Great Cheverell provides a post office/store, public house, village hall, primary and nursery schools and the 'Dauntseys' school is only a short distance. The market town of Devizes provides a wider range of shopping, leisure and educational amenities. The historic cities of Bath and Salisbury are both about 20 miles away.

It is recommended you check your web browser will allow you to bid in good time as some browsers' security can block the ability to bid. We recommend using Google Chrome when possible.

Legal Pack

You can download or pre-register for the legal packs via our website www.strakers.co.uk by using the 'Menu' at the top of the page and selecting 'Auctions', then 'Current Auction'. This will produce a lot list. Find the lot of interest and click 'View Legal Documents'. You will need to sign-up by entering your email address and creating a password the first time you use this, your log-in will stay valid for all of our future auctions. The legal pack may not be available straight away, but as long as you have registered to receive it you will be notified as soon as it is available.


Reserve & Guide Price


