Dinas Farm fields is held on a freehold basis which is shared with other chalet owners (commonhold). There is a management committee and secretary. Details of payments not yet obtained., and are in the region of £250 per year to cover water, sinking fund, grass cutting and maintenance of communal areas. Occupation is allowed for 10 months of the year. Holiday use by family and friends allowed, but not commercial holiday letting. Permanent occupation is not allowed.

A5025 towards Moelfre. In just under a mile there is a dip in the road and a large lay by to the right. Turn into this layby and at the bottom (by the bins) take the single lane track. Bear left (do not enter Penrhyn Point), and continue all the way down until you reach Dinas Farm house. Proceed through the gate and follow the unmade track and continue up a slight incline until it opens up into a field. Best to park here and walk down to Cliff Top which is the first on the left.


