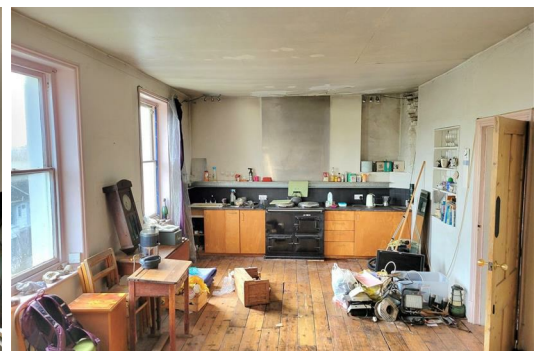

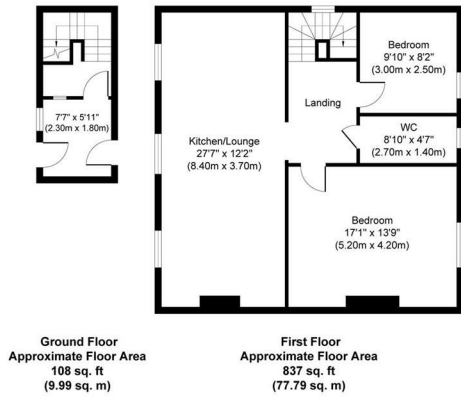

Situated within this ever popular residential location just off Upper Lewes Road close to many local facilities whilst a regular bus service provides entry into the city centre of Brighton.

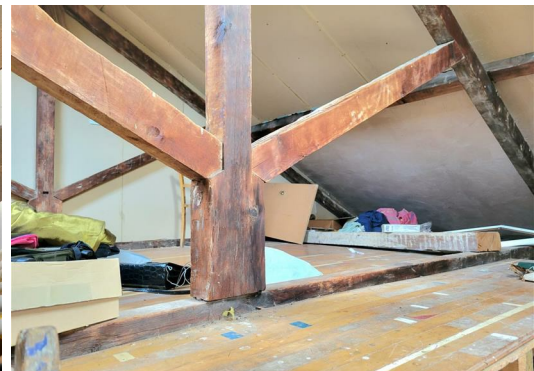
