The accommodation is well arranged over 3 floors and from the grand galleried reception hall with elegant American oak staircase to the luxurious fitted Smallbone kitchen with a range of Sub Zero and Wolf appliances, Pencarrow exudes quality and style. State of the art facilities can also be found throughout including under floor heating in main conservatory, air conditioning, mood lighting and multi-room audio/visual entertainment system. The reception rooms are spacious and well arranged for entertaining on a grand scale as well as being equally well suited for family living.
