DESCRIPTION

This architect-designed modern barn offers open-plan living with abundant light and views of nature. It is crafted to the highest specification with a stunning and contemporary look.

Approached via a communal driveway with security gates, White Barn offers architect-designed living, styled with a chic contemporary look, exquisitely crafted to the highest specification, and with unparalleled attention to detail. Open-plan living is ideal for entertaining, and the property offers spacious, secluded and flexible accommodation.

Starting from the glazed double-height reception hall, with 2.7m high ceilings on the rest of the ground floor, the house is designed to receive abundant natural light throughout. The magnificently equipped kitchen/dining area, with bifold doors opening to the landscaped garden, a spacious reception room, another living room/snug room, a utility room and a cloakroom on the ground floor offer the best in contemporary and comfortable living.









On the first floor, the principal bedroom suite enjoys a dressing room and bathroom with a walk-in shower. There are three further bedrooms and two bathrooms, one en suite. In addition, the first floor benefits from a spacious family room/home office with a double-height ceiling, set immediately above the double garage.

The second floor houses a further bedroom, a fully-fitted bathroom, an entertainment room, a fully-fitted utility room and a server/network room. Subtle Lutron mood lighting complements the integrated 1-Gbit Cat6 ethernet networks for data and home entertainment systems, bringing the home to life with the latest technology.

White Barn is set in a gated development of 4 select houses, with a private plot of 1.3 acres (0.3-acre garden and 0.95-acre woodland) in a stunning rural setting. In addition, it has a 25% share of the communal meadow.
