On entering the house, you are welcomed by a spacious entrance hall which doubles as a study, this leads to a sitting room with beams and an inglenook fireplace. This flows into the dining room and a bright, triple-aspect kitchen with built-in appliances, an Aga and doors to the patio and garden. The ground floor also includes a utility room and WC. Two staircases lead to separate first-floor areas. One leads to an oak-vaulted bedroom suite with a bathroom, cathedral window and balcony. The main staircase leads to three bedrooms, two with en-suites, including a principal bedroom with a vaulted ceiling.

The landscaped garden features colourful borders, a lawn and a terrace for outdoor dining. Two driveways offer parking and outbuildings include a workshop, potting shed, bike shed and greenhouse—providing exceptional versatility for hobbies, working from home or storage.
