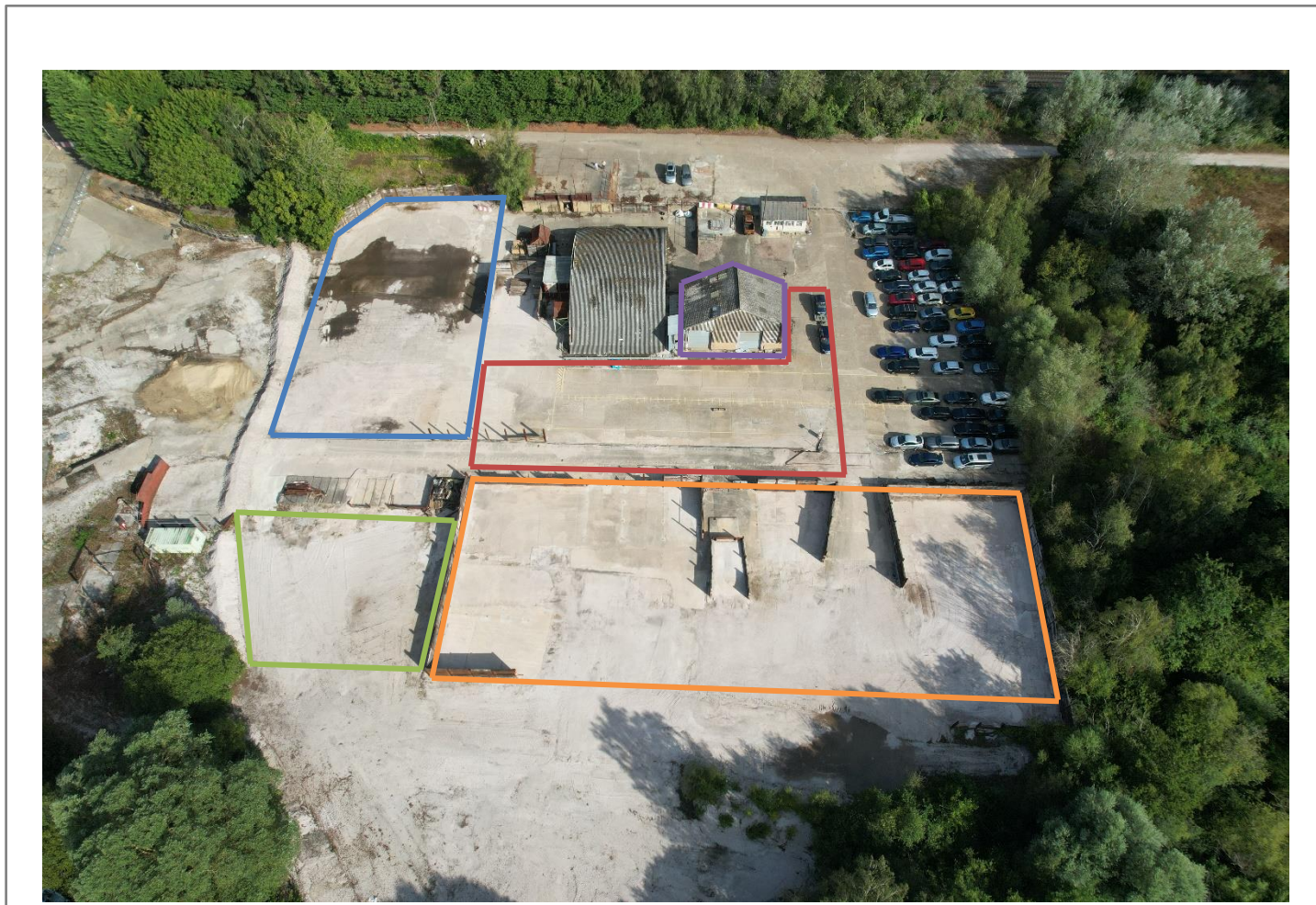

Each yard can be individually fenced upon request, but is within a secure, gated compound.

There is an additional commercial unit available in conjunction with the adjacent yard space of 150sqm (1600sqft).

**Situated**

The yard is situated in a convenient location in Fordwich, on the outskirts of Canterbury.

**Tenure**

The yard areas will be offered for rent under a lease agreement for an initial period of up to three years, contracted out of the Security of Tenure provisions of the Landlord and Tenant Act 1954.

**Services**

There are no services connected to the yard area currently, however, electricity and water may be connected for an additional charge. There is an electric connection in Unit 1.

**Business Rates**

A proportion of the sites Business Rates will be payable by the tenant to be worked out on a percentage of the occupied area.

**Landlord's Legal Costs**

The ingoing Tenant will be responsible for contributing towards the Landlord's legal costs.

**Deposit**

A deposit equal to two months' rent will be payable.

**Rent**

The rents will be payable quarterly in advance.

**Insurance**

The insurance premium is to be reimbursed to the Landlord at cost.

Canterbury City Council
