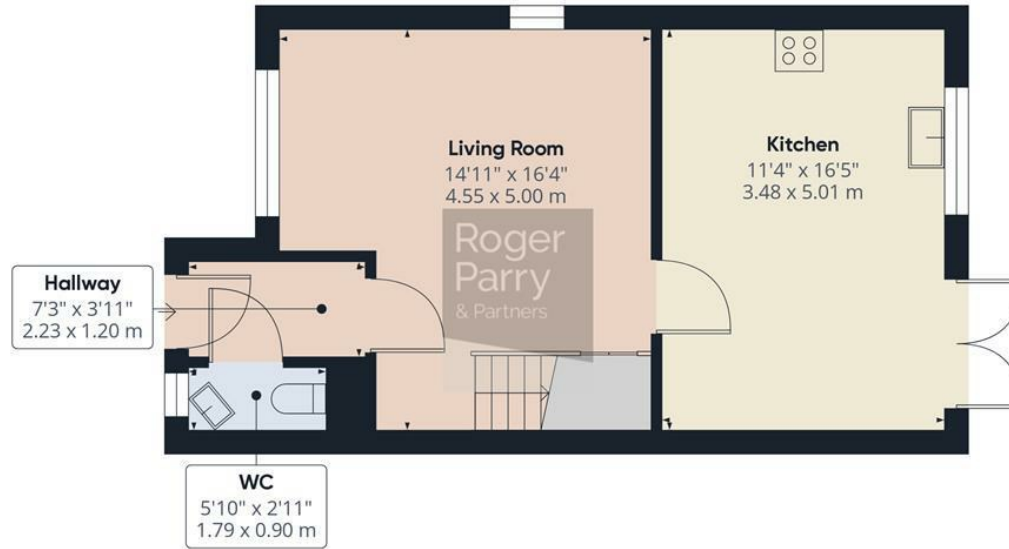

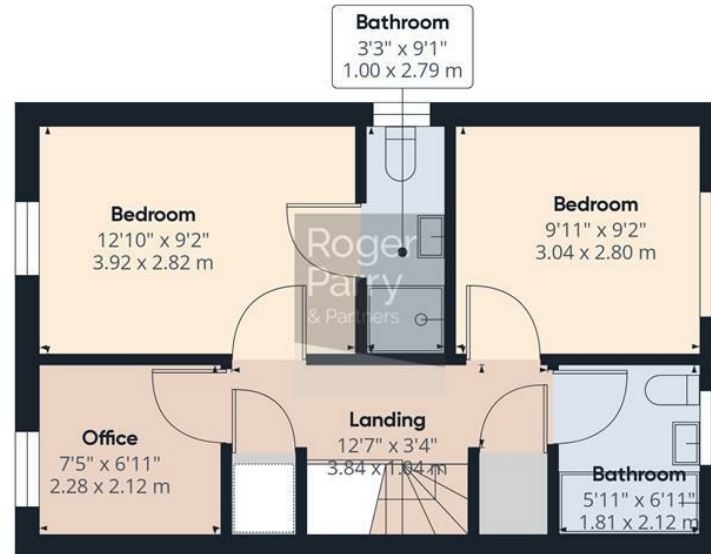
HOLDING DEPOSIT
