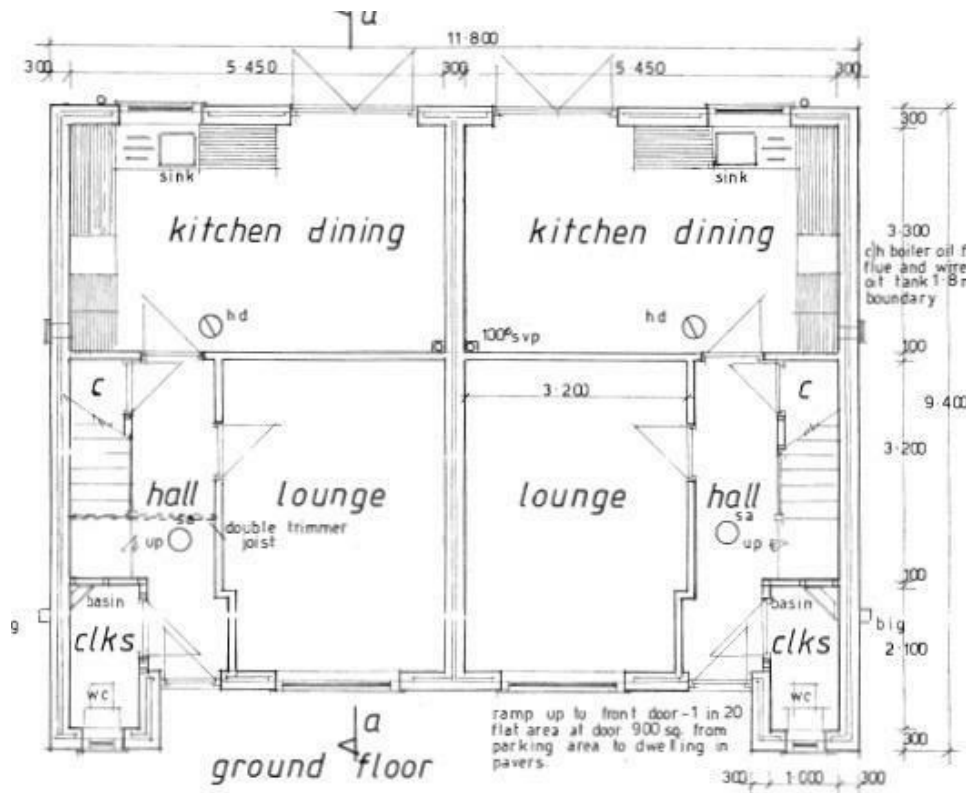

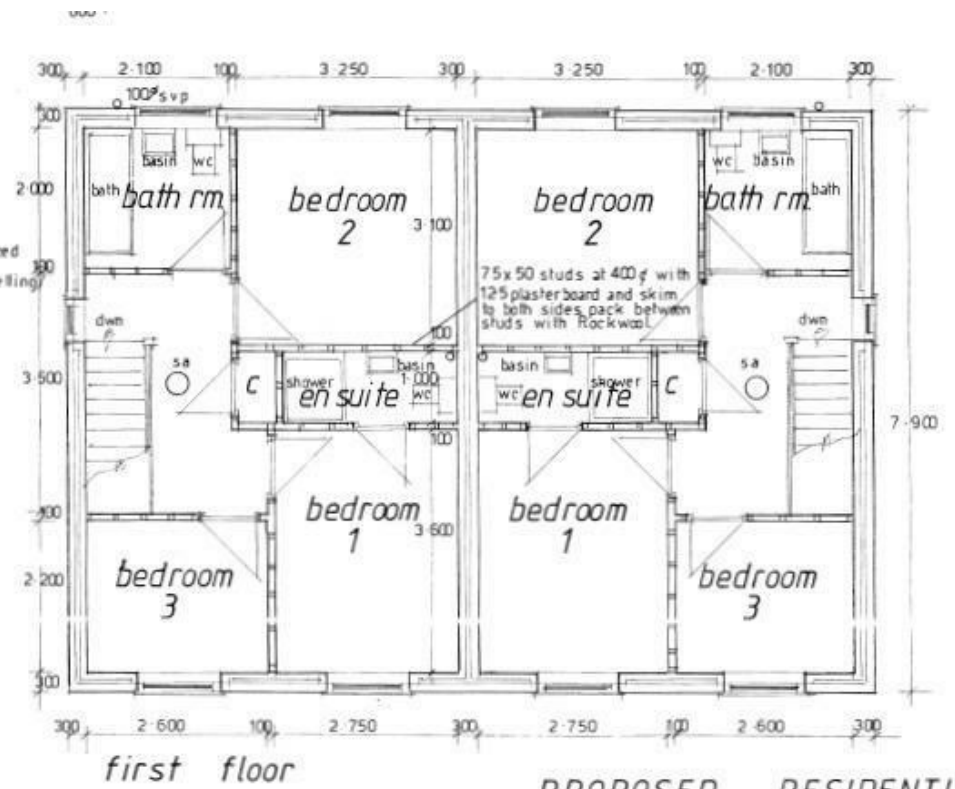
HOLDING DEPOSIT
