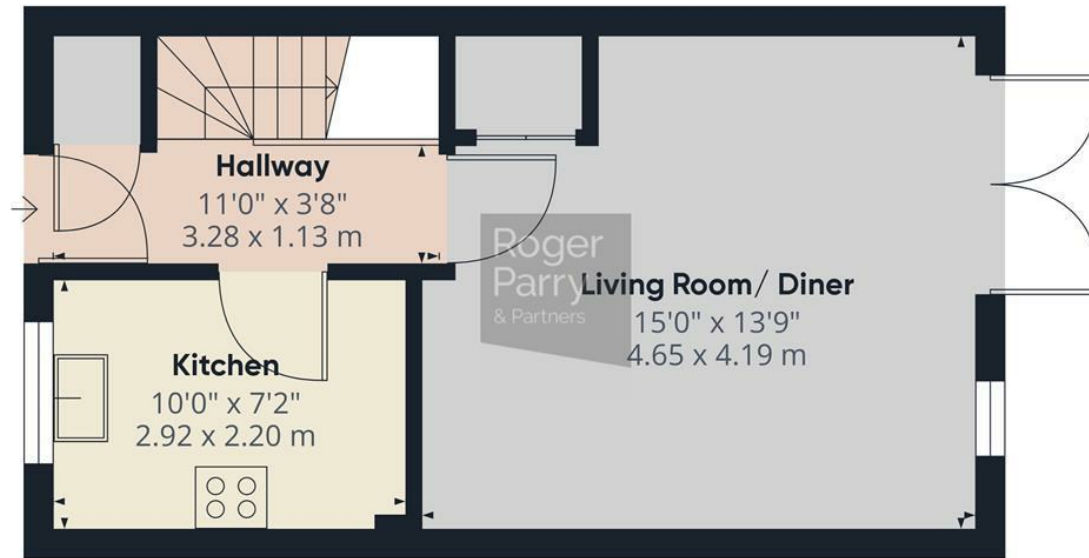

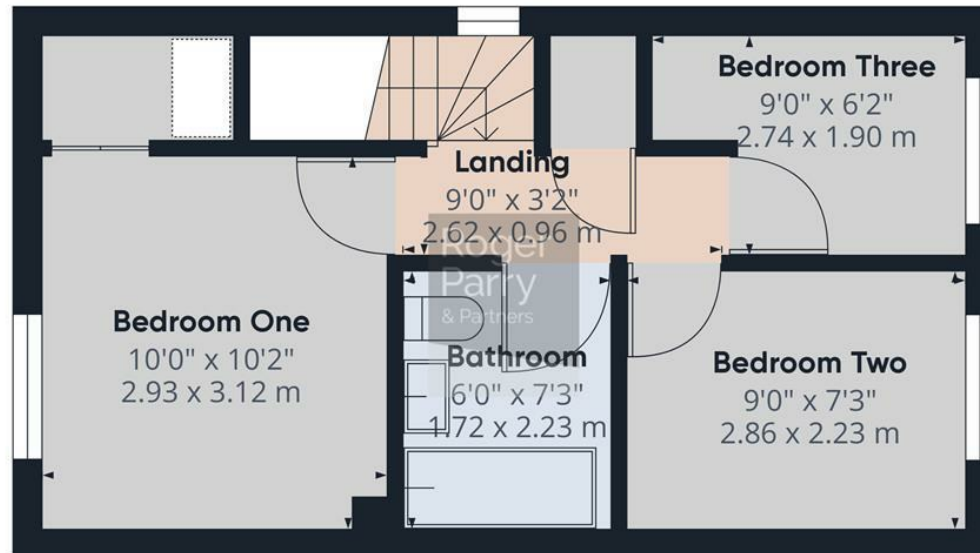
HOLDING DEPOSIT
