The house is entered through a porch at the front of the house ideal for coat and shoe storage. The lounge is a generous size and has access to the staircase leading to the first floor landing. The lounge then leads to the dining room, with under stairs storage cupboard and space for dining table. Kitchen which is fitted with a range of contemporary wall, base and drawer units with integrated hob, oven and extractor hood and space for washing machine and fridge/freezer. Rear hallway with door giving access to the yard. Bathroom with three piece suite, including bath with shower above.

To the first floor there are three bedrooms, the main being a generous size double with built in storage/wardrobes.

Outside the house has a garden to the front with gated access and directly to the rear there is an enclosed yard. Over the back lane there is a further garden area and would be ideal for patio areas or keen gardeners.

Valley Terrace is located in the popular village of Howden Le Wear and has primary school, post office/village shop and is on a regular bus route, giving access to neighbouring towns including Crook and Bishop Auckland.
