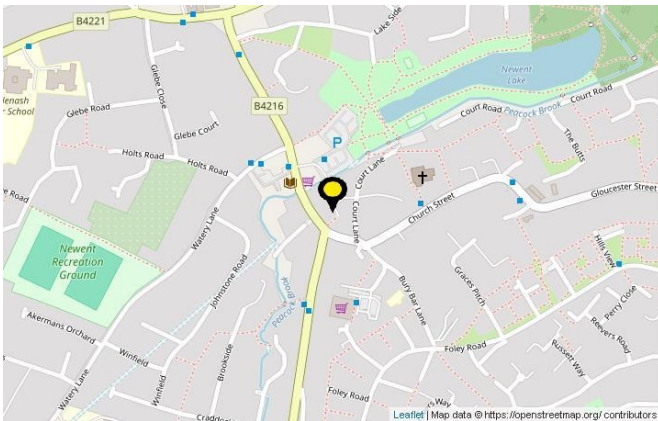

Location

Newent is an attractive and thriving unspoilt town, with an expanding population with significant residential expansion of the town already underway. There is a range of attractions for shoppers and visitors. Many of the buildings date from the thirteenth century and the centrepiece of the town is the Old Market Hall which was built in 1668. The town is approximately 10 miles from Gloucester, 9 miles from Ledbury and just 4 miles from Junction 3 of the M50.

Description

The retail shop forms part of a grade II listed property and enjoys a prominent town centre location with excellent frontage. The premises extend to approximately 463 sq ft and the space lends itself to a variety of uses subject to necessary consents. Viewing is highly recommended.
