SITUATION

The land lies north of the B3220 about 1.3 miles south east of Coldridge in Mid Devon. The A377 at Morchard Road can be reached about 2.7 miles to the east and Winkleigh is 8.5 miles to the west.

Crediton lies a short distance to the east which has amenities and services typical of a small market town including various shops, schools, a leisure centre, agricultural merchants, churches and other continence stores.

The surrounding countryside is mostly used for arable and livestock farming. The fields lie within Grade 3 land and the soils are described as freely draining, slightly acid loamy.

DESCRIPTION

The land comprises two fields which together extend to about 18.11 acres. In recent years the southern field has been used for arable cropping on rotation and the northern field has been under pasture. The fields are surrounded by mixed hedges with road frontage to the south and slope gently to the north east.

The northern parcel can be reached by a connecting gate between the two fields or by Cleaveanger Lane which is an unmetalled track.

Situated in the most northern corner of the land is a corrugated steel field shelter. The structure would require repair to bring it back to a functional use.

ACCESS

The land is reached directly from the public highway. Access to the northern field is by a established right of way over Cleaveanger Lane .

SERVICES

There are no services connected.

METHOD OF SALE

The land is offered for sale by private treaty as a whole.

The land is held freehold and is available with vacant possession on completion.


