STAGS

SITUATION

The land is situated about 1.5 miles south of Tavistock town centre and lies to the west of Crowndale Road. The A386 runs to the north of the land which connects Yelverton in the south to the A30 at Sourton Down in the north.

The local area is typically used for agriculture although development is encroaching from the southern limit of Tavistock.

Tavistock has a good range of local amenities including a busy town centre which boasts many shops. The town also benefits from a livestock market and a number of commercial outlets.

DESCRIPTION

The land extends to about 17.77 acres and comprises two gently sloping pasture fields separated by stone-faced banks. The boundaries are fenced and mostly grown up hedging with trees.

There is a small area of woodland to the south which

abuts Tavistock canal.

There may be livestock on the land. Please take care around any stock and leave gates as they are found. No dogs are permitted on the land during viewings.

SERVICES

There are no services connected to the land

ACCESS

The land is reached by a right of access from the public highway between points A and B of the route shaded yellow on the sale plan.

The land is available freehold with possession subject to an existing farm business tenancy. Notice has been served and vacant possession is available from March 2026


