









# Floor Plan Area Map




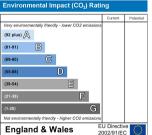
