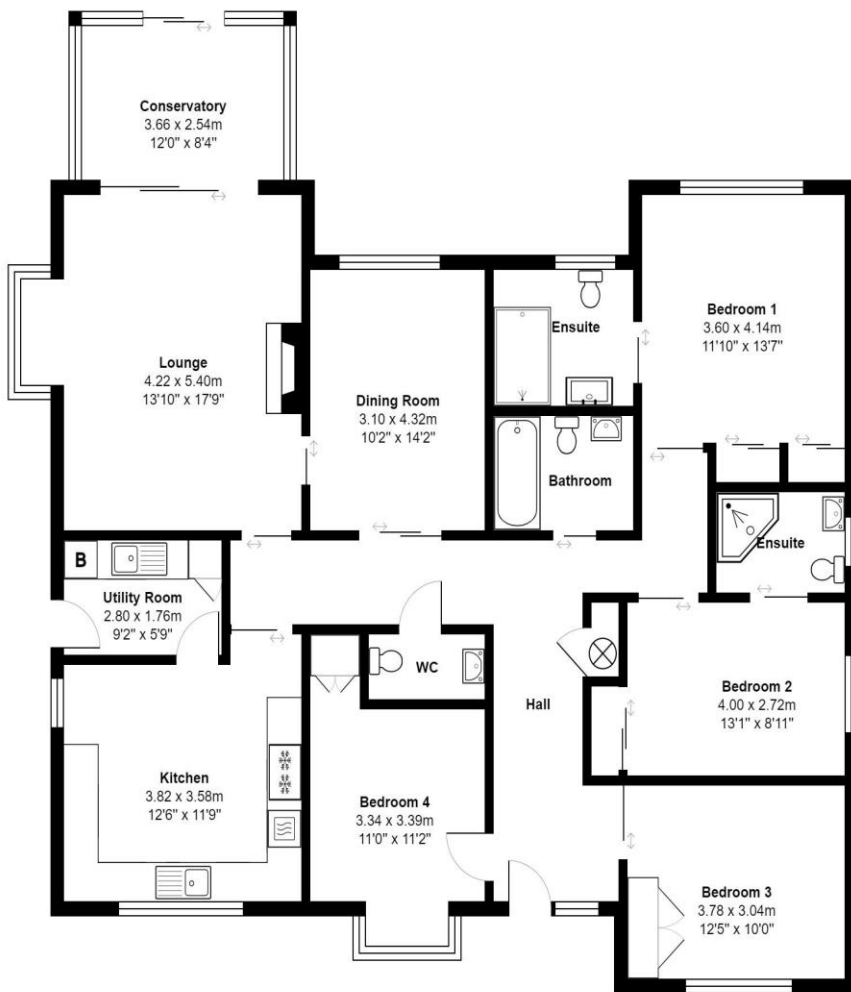

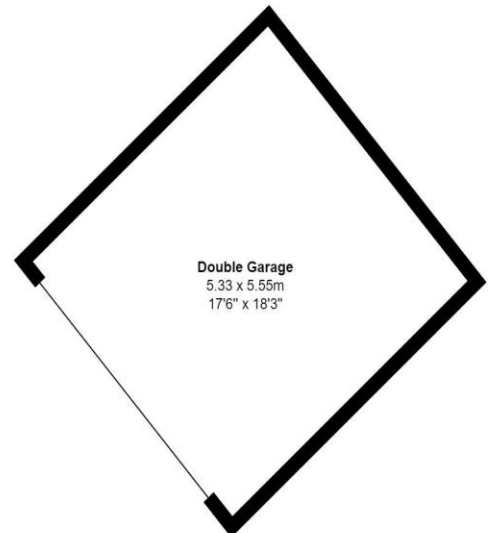

There are two pubs in Alveston and Rudgeway and the village has a primary and secondary school, with a large new SEND school opening in September 2024, a church and a village hall. The property is near to Thornbury Golf Course, a Leisure Centre and the surfing centre, The Wave.
