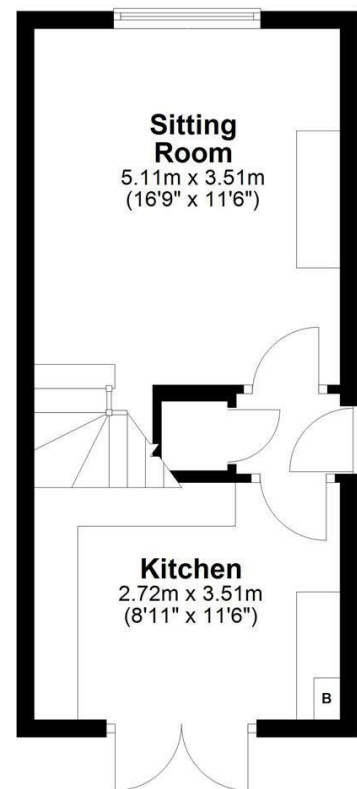
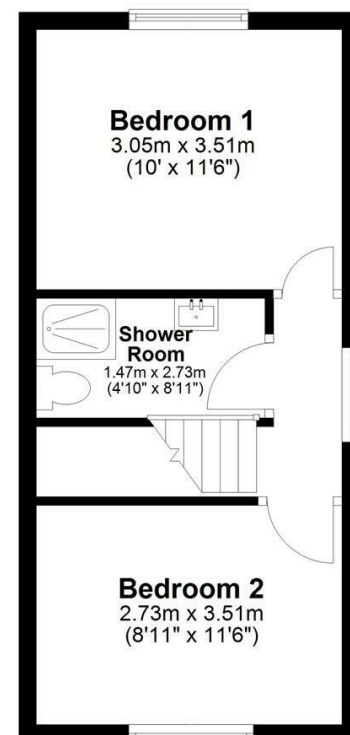

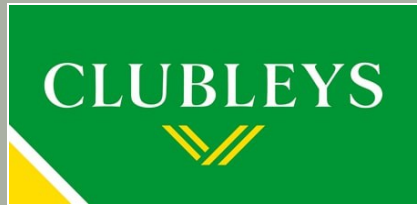

Having a double glazed window to the front elevation, radiator, stairs to the first floor accommodation, gas fire in feature surround.
