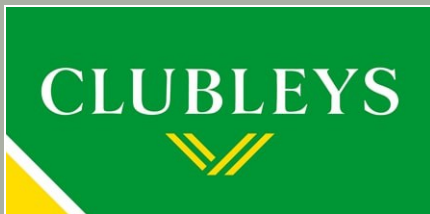

#### THE ACCOMMODATION COMPRISES

##### GROUND FLOOR

###### ENTRANCE HALL

Front door leads into the entrance hall.

###### LIVING ROOM

3.54m x 5.32m (11'7" x 17'5")

Spacious living room with under stairs storage cupboard and stairs off to the first floor. Tv and telephone point.

###### DINING KITCHEN

4.54m x 5.32m (14'10" x 17'5")

Good range of modern wall and floor units with complimentary work surfaces and splashback incorporating a stainless steel sink unit, integrated oven, four ring gas hob with stainless steel splashback and chimney extractor over. Feature bi fold doors lead into the rear garden. Vinyl flooring.

Block paved driveway to the front of the property providing parking for two vehicles. Side access gate leads into the rear garden, laid mainly to lawn with paved patio area adjacent to the property and to the rear of the garden.

##### SHARE PURCHASE PRICE AND EXAMPLES

The percentage share and rent amount will change depending on the amount you can afford. You'll receive a worked example after a financial assessment.

##### RESERVATION FEE

You'll need to pay a reservation fee to secure your home. When you pay the fee, no one else will be able to reserve the home.

The reservation fee secures the home. If you buy the home, the fee will be taken off the final amount you pay on completion. If you do not buy the home, the fee is not refundable.

##### ELIGIBILITY

You can apply to buy the home if both of the following apply:

- your household income is £80,000 or less
- you cannot afford all of the deposit and mortgage payments to buy a home that meets your needs

One of the following must also be true:

- you're a first-time buyer
- you used to own a home but cannot afford to buy one now
- you're forming a new household - for example, after a relationship breakdown
- you're an existing shared owner, and you want to move
- you own a home and want to move but cannot afford to buy a new home for your needs

If you own a home, you must have completed the sale of the home on or before the date you complete your shared ownership purchase.

As part of your application, your finances and credit history will be assessed to ensure that you can afford and sustain the rental and mortgage payments.

Under a shared ownership lease, you pay for a percentage share of the market value of a home. You enter into a lease agreement with the landlord and agree to pay rent to the landlord on the remaining share.

##### LANDLORDS NOMINATION PERIOD

When you give the landlord notice that you intend to sell your share in your home, the landlord has 4 weeks to find a buyer. The landlord may offer to buy back your share, but only in exceptional circumstances and if they have funds available. If they do not find a buyer within 4 weeks, you can sell your share yourself on the open market. For example, through an estate agent.

##### PETS

You can keep pets at the home.

##### SUBLETTING

You cannot sublet (rent out) your entire home unless you either:

- own a 100% share; or
- have your landlord's permission which they will only give in exceptional circumstances (see section 1.5 in 'Key information about shared ownership' document)

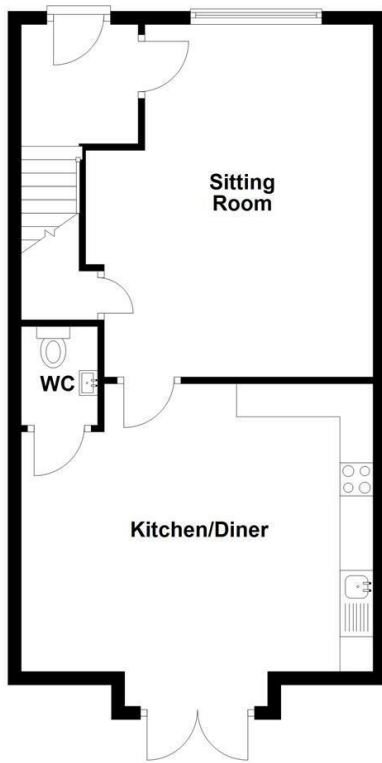

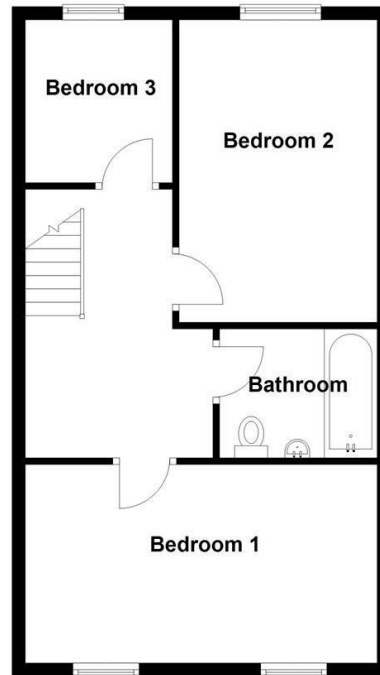

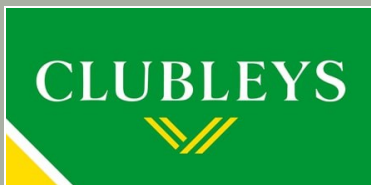
