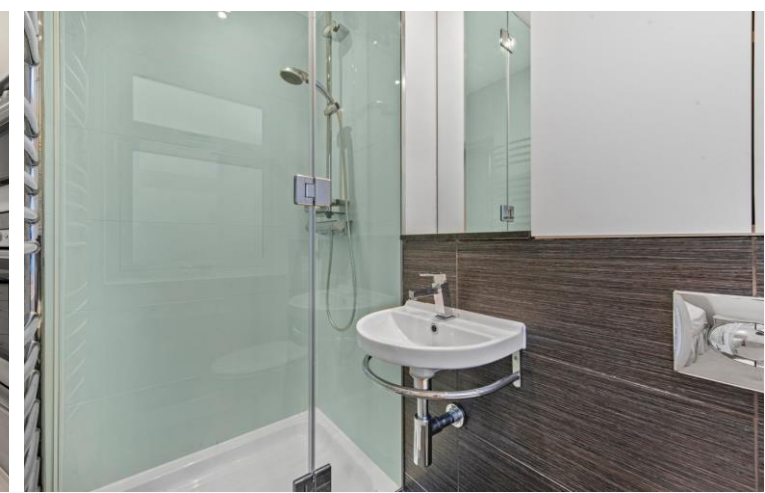

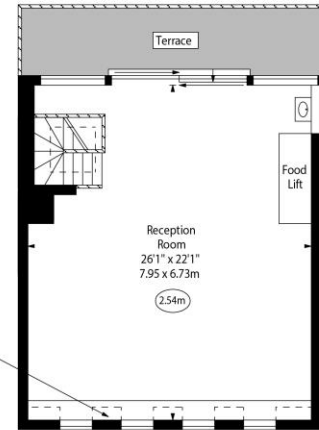

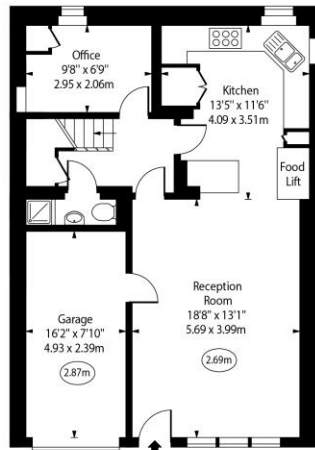


○ - Ceiling Height

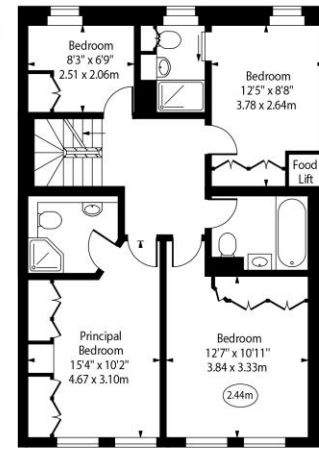
Restricted
