SITUATION

Tucked away in a quiet rural valley, the land is positioned just a short distance from the historic market town of Liskeard, which offers a comprehensive range of facilities including shops, schools, healthcare and a mainline railway station providing direct access to Plymouth and beyond via the A38 corridor.

Access to the land is via a byway that runs alongside the eastern boundary, linking to parish roads at either end and offering ease of approach while maintaining a sense of seclusion.

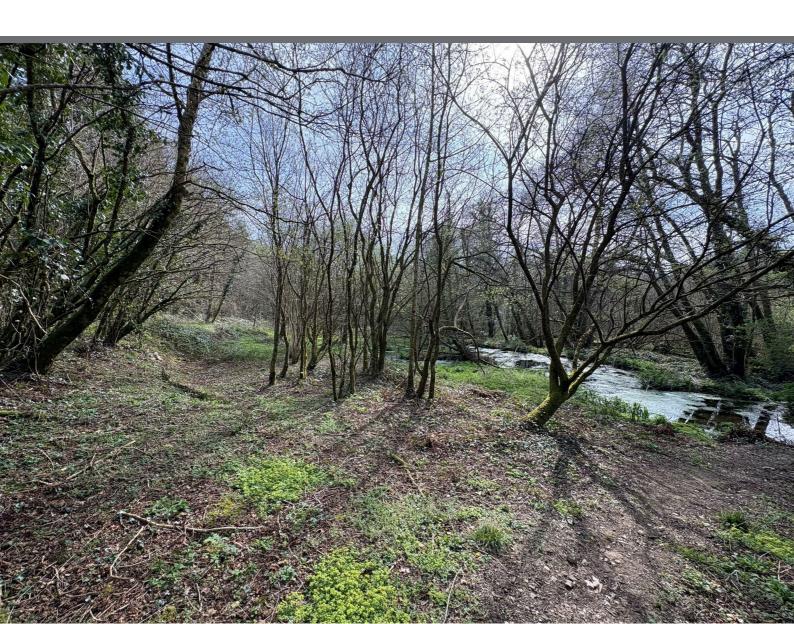

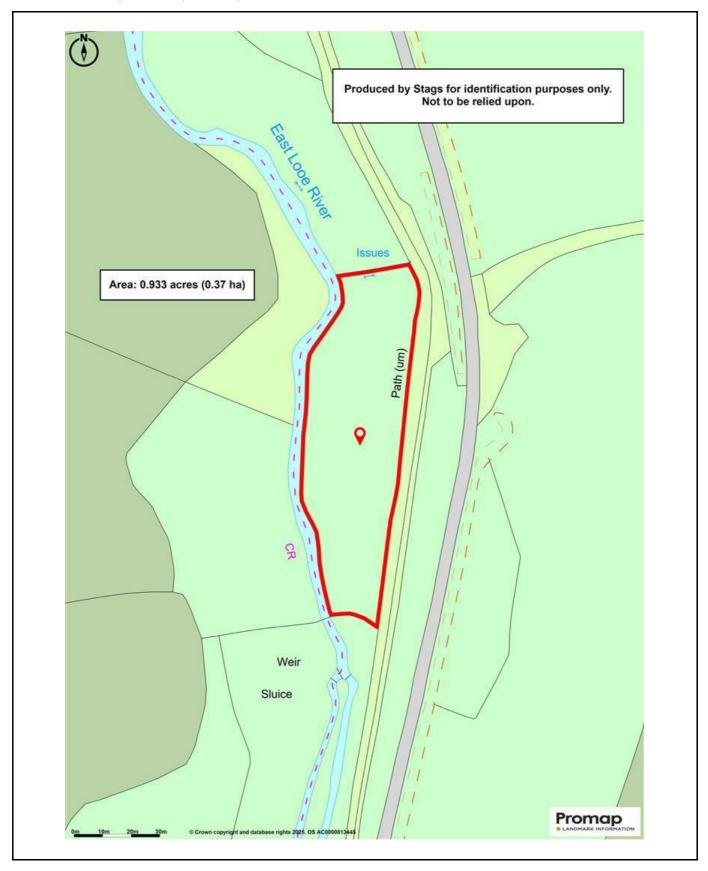
