Ideally situated near the heart of this highly sought-after village, the property enjoys easy access to a range of local amenities including a church, village shop, hairdresser, dentist, garage, hall, and a well thought of primary school. The renowned King's School and wider facilities can be found just a short drive away in Ottery St Mary.

Built in the late 1970s of block under a tiled roof and bought off-plan by the current owners, this much-loved home has been carefully maintained and thoughtfully updated. Recent improvements include a sleek, modern kitchen, stylish en suite, and a striking new staircase. Designed in a mid-century modern style, the property offers bright, well-proportioned rooms, generous ceiling heights, and large picture windows.

A private drive leads to a generous parking area and double garage. The gardens are a real highlight, with a level lawn wrapping around the house, a greenhouse, timber shed, and a spacious terrace ideal for outdoor entertaining. At the rear, a large patio overlooks mature, well-stocked borders and a magnificent Magnolia tree. Below, a fenced asphalt tennis court is neatly sheltered by established hedging.

The property benefits from PV solar panels, mains gas, electricity, water and drainage, along with a recently replaced gas boiler. Ultra-fast broadband is available (up to 1,800 Mbps), and mobile signal outside with Vodafone, EE, Three and O2, although data on O2 may be more limited (Ofcom).


